	Fee is for one 12ft x 12ft space only on a first come first assigned basis. Deadline is Dec 31, 2021.
	No personal checks will be accepted. No refunds for cancellation due to increment weather or no shows.
	Occupational licensing, security and limited electric power access (2 standard 110V) are included in space.
	You must provide you own tent, and table. Exceeding your space requirements will result in removal.
	NO ANCHORING OF TENTS OR SECURING ITEMS USING STAKES OR SPIKES IN ASPHALT PARKING LOT. Sandbags or weights are only permitted to secure from windy conditions.
	You must keep the area around your position free of litter and the paved area around your position.
	Your vehicle is NOT permitted in the vendor area from 12noon to 5pm.
	You must SET UP and TAKE DOWN at your designated time.
	You must accept the location assigned to you by the committee.
	You may not use any public-address system or musical amplifiers.
	Ensure you have hygiene items available for patron(s).
	You may sell ONLY the items submitted on page 2 and accepted by the Vendor Committee, who will notify you of your accepted ITEMS. You will be closed if such items not listed are present and you will forfeit your entire paid amount.
